The Trustee Ordinance, Ch. 4 of 1939

REGULATIONS

Made by the Minister of Legal Affairs under section 10F of the Trustee Ordinance

THE TRUSTEE ORDINANCE (PRESCRIBED FORMS AND FEES) REGULATIONS, 2024

- 1. These Regulations may be cited as the Trustee Ordinance Citation (Prescribed Forms and Fees) Regulations, 2024.
- 2. The Forms contained in Schedule 1, are the forms required to be Forms for prescribed by Regulations by the Minister of Legal Affairs under sections sections 2A (3), 10C and 10D, of the Ordinance.
 - 3. (1) The forms prescribed by these Regulations shall be $_{\mbox{\scriptsize Requirements}}$ submitted—
 - (a) on good quality white paper approximately 8.5 inches by 11 inches in size;
 - (b) printed or typewritten; and
 - (c) legible and suitable for scanning.
 - (2) Where an item of information required to be disclosed in a form does not apply, it shall be so indicated by the phrase "not applicable" or by the abbreviation "N/A".
 - (3) Where information is set out in response to one item in a document, it may be referred to in response to any other item in that document by a cross reference.
 - (4) Where—
 - (a) any provision required to be set out in a form furnished to the Registrar is too long to be set out in the space provided in the form; or
 - (b) an agreement or other document is to be incorporated by reference in and is to be part of the form—

the person completing the form may, subject to subregulation 3(1), incorporate the provision, agreement or other document in the form by setting out in the space provided in the form, the following sentence:

- "The annexed Schedule is incorporated in this Form.", and by annexing the provision, agreement or other document to the form as that Schedule.
 - (5) A separate Schedule is required in respect of each item that is incorporated in a form by reference, pursuant to subregulation (1).
 - 4. The fees payable under the Act are set out in Schedule 2.

Definition of Beneficial Owner

- (b) any other natural person exercising ultimate effective control over the trust/legal arrangement either directly or indirectly, including through a chain of control or ownership.

Format
